Inhalation of vapours in high concentration may cause metal fume fever and may cause damage of the central nervous system in case of repeated and prolonged exposure. Repeated and prolonged exposure to high dust concentrations may lead to irritation of the respiratory tract. Inhalation of metal-containing dusts may cause acute poisoning, leading to nausea, vomiting and abdominal pain. Extended exposition through inhalation of nickel dust and flue gas may lead to lesions, incl. fibrosis. Nickel contaminated dust that is transferred by the ambient air is considered cancer-causing when entering the depths of the respiratory tract. Metallic nickel and all its compounds may have a sensitising effect, in particular with persons with general proneness to allergies.
